

OCEAN 98.5 Daily Prizing

OCEAN 98.5 has lots of chances for you to win great prizes! Listen to OCEAN 98.5 from 5:30AM to 7PM for your chance to win.

Here are the Rules and Regulations for OCEAN 98.5 daily prizes. If there are any discrepancies between these rules and regulations and any other rules and regulations posted for any particular Contest (the "Alternate Rules"), such discrepancy shall be resolved in favour of the Alternate Rules:

CONTEST RULES
